3. Report of the Board for the Year

Vision

The Silkmen Supporters' Trust is committed to the improvement and development of Macclesfield Town FC by working in partnership with the Club, the fans and the community to the mutual benefit of all.

Objectives

In June 2015, the SST Board defined and agreed a new set of objectives for the Trust:

- 1. To work with the Club to improve the match-day experience for supporters
- 2. To provide a communication bridge between the fans and the Club
- 3. To be a channel for the Club to communicate with supporters
- 4. To recruit as many members to the SST as possible so as to be truly representative of the fan base
- 5. To provide benefits for our members
- 6. To identify supporters' issues, assess them and, where appropriate, try to resolve them with the Club
- 7. To encourage the raising of funds that are used for the benefit of supporters, the community and the Club
- 8. To encourage supporter led projects and initiatives and, where appropriate, provide them with financial, administrative and media support
- 9. To seek permanent SST representation in the governance structure of the Club

Activities

During the year, the Trust board has achieved the following:

Fundraising

- Held an auction of donated paintings raising £200
- Increased easyfundraising membership to 50 members raising £184
- Organised a Christmas Raffle raising £950
- Silk Pledge raising £2,046
- Provided assistance to other fundraising activities. The SST continued to manage the accounts for the Silk Lotto which has now raised its monthly donations to the Club to £500 and also made a one-off donation of £1,000. The SST also played a major role in the management of the SOS Player fund, managing the accounts, providing an address for and collecting of postal donations and organising payments to the Football Club.

SST Structure

- Developed the nine new objectives outlined above and communicated them to members and the Club
- Developed a new and vastly improved website

Expenditure

- Purchased the trophies for the Player of the Year Award
- Sponsored the Manager's kit

- Given £400 to the Club to help refurbish the London Road Refreshment kiosk
- Given £500 to the Club to purchase merchandise in return for discount vouchers for members in the Club shop
- Made a £1,000 share purchase
- Given £3,000 to the Club to assist in the signing of Danny Whitehead

Club Liaison

• Established regular meetings with the General Manager of the Football Club

Other Activity

- Negotiated FA Cup ticket priority after season ticket holders for members and also a 10% discount on the hire of the McIlroy suite along with the previously mentioned Club Shop Discount Vouchers
- Done voluntary work on behalf of the Club SST Board members were active in working in the Club Shop, the Club Office and selling 50/50 tickets
- Use of SST social media to promote Club activities and requests for volunteers
- Sponsored a Man of the Match and held a draw for four members and guests to attend the Man of the Match dinner
- Supported and been directly involved in the Homeground Arts Council funded project
