09/07/02 Meeting with Mark Blower

A discussion took place regarding the meeting with Mark Blower and the explanation that the money that Amar had taken out from the club had been repayments of short term loans. It has also been reported that the Club had not received the payment from the FA for the FA Trophy Game and this would appear to answer the comments made on Wraggs with regard to the players having not been paid their bonuses.

09/07/03 Elections

The process is in hand for the election of new members and existing members requiring re-election to the board. The closing date for the nominations will be 19/8/17 with the first ballot being 1/10/17. The board will be announced at the AGM in November. A discussion was held to look at ways into which new board members could be encouraged to join. It was felt that more meetings could be held as open meetings therefore encouraging people to attend to see if they would be interested in joining the board. It was also suggested that people could be discouraged by the formal election process and that it may be worth trying to co-opt people to begin with.

09/07/04 Membership

Steve reported that the Trust has recently agreed the payment of £430 for a sit on mower for the groundsman. Marie reported that the Lotto had also paid out £200+ for the purchase of a strimmer for him. The Lotto have also paid the club money for the development of "Rory's Den" for children under the concourse. This will be used by the Youth Officer to encourage children's parties and somewhere where on match days children can spend some time on computer games before games and during half time.

Myra enquired if we wanted to run a raffle again this Christmas and it was agreed that we should. Myra to look to getting tickets printed. It was suggested that Arighi Bianchi could be approached to offer a prize. **Action: Myra to make enquiries**

09/07/06 Communications
