1 Welcome by Chairperson.

The meeting was opened and everyone welcomed at 8.10pm by the Chairperson AW.

2 Apologies.

3 Finance.

A financial update was given by JA. A copy of his report is at Annex A to these minutes.

Hardship Fund. It was agreed to leave further discussions about the future of the hardship fund until the SST Board meeting in October when the future direction of the club should be much clearer.

Concern was raised by JA about the number of people participating in the Silk Lotto. The figure has dropped below 200. AW indicated that Robert Stirling had initiated discussions with interested parties to increase membership.

4 Membership.

BR stated that there was confusion with people joining via paypal as their email addresses were not coming through. BR & JA will look at this problem. BR also updated the Board on the ongoing work to make it easier to join the SST online. The new email form was almost complete.

5 Communications.

6 <u>Board Elections</u>.

7 <u>Board Roles</u>.

8 Conflict of Interest.

RW briefed the Board on conflict of interest questions raised by the fanbase. The advice from our governing body, the Football Supporters association (FSA) is that there is no conflict of interest provided Board members working for the club follow the SST constitution and do not disclose any confidential SST/FSA information to the club and vice versa.
